This part-time contract is for executing soil science laboratory tasks and experiments in the context of the AGAUR funded project, Sòl-Saver. Briefly, the project aims to understand changes in soil health with regenerative practices on farms across Catalonia. The employee will be charged with carrying out physico-chemical analyses of soils in the laboratories of Agrotecnio.

The ideal candidate may be 1) a Masters student of a relevant field (soil science, forestry, agronomic sciences), whereas the results can serve as the basis for a Master's project – effectively, the Master's project would be a paid internship. Alternatively, 2) the candidate may be in the 3rd or 4th year of the agronomic or forestry sciences. In all cases, experience and interest in laboratory tasks is highly desired. This will be a criterion for selection.

No specific merits are required, however, if already obtained, a digital copy of the Bachelor's degree should be presented in the application package.

Application package consists of a single digital file (PDF) containing:

- CV of maximum 2 pages detailing academic and professional experience
- Separate (maximum 1 page) statement of interest in the position, describing most relevant experience, and expression of intention (or not) to exploit the results obtained in an academic course at the UdL (e.g. final degree project, Master's project).
- Any relevant academic degrees (digital copy)

Evaluation will be based on:

- Academic background relevant to soil science, forestry, agronomy, or related disciplines.
- Motivation and interest in the position and the proposed research activities.
- Laboratory experience and aptitude, or demonstrated interest in laboratory work.
- Overall suitability and potential, considering academic achievements, relevant experience, and practical skills.
- Intention to develop the obtained results into a Bachelor's or Master's thesis/project at the University of Lleida (desirable, but not required).
