Technician for the Demostrative Project

The technician contracted will work in a project that aims to train advisors and farmers to integrate technological packages that are commercialized and integrate them with the decision support technology developed by Agrotecnio in the framework of integrated weed protection. Thus, sensors will be used to study the variability of the soil and with this information, variable dose treatment maps will be generated. Image recognition technology will then be used to detect the presence and location of the weed species to be controlled based on the recommendations of the IPMWise DSS taking into account the specific species and its stage of development. With this, a reduction in the use of plant protection products is expected to be greater than 30% compared to usual practice.

Clear and precise description of the activity

The candidate must monitor the project tests: Selection of plots, taking samples, evaluation of results and processing them. The possibility of carrying out the TFM within the project is offered.
